DELAY IN 10TH BIPARTITE WAGAE REVISION NEGOTIATIONS

We reproduce hereunder the text of All India Bank Officers' Confederation Circular No. 52, dated 6th August, 2014.

Please refer to our circular No. 2014/49 dated 16th July, 2014, whereby we informed you that subsequent to submission of Memorandum to the Hon'ble Finance Minister on 27th June, 2014, UFBU meeting was held on 15th July, 2014 at Mumbai and it was unanimously decided i) to send a communication to IBA for conduct of meeting on wage negotiations immediately without any further delay and also for conduct of such meetings at frequent intervals and ii) to approach Government once again seeking intervention of Hon'ble Minister of Finance towards expeditious wage settlement, who had been preoccupied with Budget Exercise and Parliament Session, so far.

As per the decision taken in the meeting of UFBU, a communication was sent to IBA on 16/07/2014, which was annexed to our aforesaid circular, response to which is still awaited. Meanwhile, Convenor of United Forum of Bank Unions has sent another communication to IBA asking for immediate dialogue on the salary revision. The letter sent by UFBU to IBA is appended below:

Comrades, since we had sought the intervention of the Hon'ble Finance Minister of India and he was busy, we are waiting for his directions to IBA. In the absence of any positive response from IBA, UFBU will decide its course of action. We call upon all our affiliates/state units and members to be in readiness for any eventuality.
