MEETING WITH EXECUTIVES OF NABARD/SPONSOR BANKS

General Secretary of our Federation during his visit to Mumbai on 9th & 10th March, 2017 held following Meetings with NABARD & Sponsor Banks.

CENTRAL BANK OF INDIA:

Meeting was held with Shri P.K. Gupta, General Manager and N.P. Singh, Asst. General Manager in regard to the following issues.

- (i) Lawlessness and biased attitude of Management in Uttarbanga Kshetriya Gramin Bank.
- (ii) Non-Payment of arrear of Salary & Allowances in Central MP Gramin Bank.
- (iii) Improvement in the Loan Scheme in RRBs.
- (iv) Implementation of Part B of other allowances as per letter of Govt. of India, DFS circular dated 20th Oct. 2016.

The issues were deliberated at length and the General Manager assured to take appropriate action.

STATE BANK OF INDIA:

Meeting took place with Shri R.V. Aswin, Chief General Manager, Agri-Business and Shri Ganeshan, Dy. General Manager, RRBs. We highlighted that despite of Meeting by Shri Y. Sudershan, General Secretary, All India State Bank Officers Federation with Dy. Managing Director, State Bank of India the RRBs sponsored by State Bank of India did not apply for Associate Membership of IBA. CGM told us that he shall follow up the matter. In regard to Part B of other allowances, the Executives told us that they would be shortly issuing instruction to RRBs to implement the same.


NABARD:

We held Meeting separately with Dr. U.S. Saha, Chief General Manager, IDD and Shri N.P. Mahapatra, General Manager, IDD on 10th March, 2016. We followed up in the matter of issue of reintroduction of Compassionate Appointment and computer increment component not implemented in some RRBs. The officials advised that they are expecting that the same shall be released within a fortnight. On our follow up on holding of next JCC Meeting, as we have already given the agenda, CGM told that by end of April next JCC shall be held to resolve the new issues.

BANK OF INDIA:

We held Meeting with Shri P.K. Pattanaik, General Manager, RRBs, Bank of India who was assisted by Chief Manager in the evening of 10th March, 2016. The long pending issue of rotation of officers was raised. It was assured by GM that by another 15 days they shall instruct RRB Chairmen to ensure rotation as per Transfer Policy and CVC guidelines. In regard to Part B of the allowances, Shri Pattanaik told us that he shall ensure uniform Scheme for all RRBs as early as possible.
