63RD MEETING OF CENTRAL COMMITTEE HELD AT ORANGE CITY, NAGPUR ON 27TH MAY, 2017 – A GRAND SUCCESS

The 63rd Meeting of the Central Committee of AIRRBOF took place in grand manner in the Ocean Blue Banquet Hall of Hotel Orient Taibah, Nagpur on 27th May, 2017. The Meeting was well organised by the comrades of Vidarbha Konkan Gramin Bank Officers' Association led by a team of Com. Satish Akre, and Com. R.D. Bhusari.

The Meeting was attended by Central Committee Members & invitees from all over the country. The Meeting was called to order by President Com. R.G. Makhija. Thereafter, the welcome address was rendered by Com. R.D. Bhusari on behalf of Reception Committee. All the leaders on the dias was felicitated by the Comrades of VKGBOA. The participants were also felicitated by offering flowers.

Agenda wise discussion was started by the President. General Secretary read out the proceedings of the 62nd Meeting held at Rajkot on 27th Nov. 2016 and explained the action taken on the same. Thereafter the proceedings were adopted unanimously.

In the next agenda an elaborate written report by the General Secretary on all developments in the intervening period was presented by Com. S.K. Bhattacharjee, General Secretary. Detailed deliberation on the report took place. Large number of comrades namely, Com. Dhananjay Kumar Singh, Com. M.V. Karer, Com. P.N. Madhusudan, Com. Srijan Pal, Com. B.L. Khandelwal, Com. Bhola Dani etc. presented their views. The following major decisions were taken:

- (i) AIRRBOF shall take all steps to pursue Payment of Pension at par both before the Hon'ble Supreme Court as well as on the discussion table with Govt. of India.
- (ii) The issue of Special Leave on account of accident while on duty should be pursued to give relief to such officers.
- (iii) The discrimination in the matter of eligibility criteria in the promotion issue being raised by the Federation should be pursued further.
- (iv) The Meeting of the Core-Committee shall take place in New Delhi, Hotel Chanchal on 10th July, 2017 at 7 PM. to review developments.
- (v) The issue of effecting promotion from Scale IV to V should be pursued by the Federation so as to fill up the vacancies of all General Managers in RRBs.
- (vi) Federation should demand that the minimum incumbency of Chairman of RRBs should be that of Dy. General Manager and that of GMs by Asst. General Manager.
