## **9<sup>TH</sup> MEETING OF JOINT CONSULTATIVE COMMITTEE HELD AT NABARD, HO, MUMBAI ON 12<sup>TH</sup> APRIL, 2018**

The 9<sup>th</sup> JCC Meeting chaired by Chairman, NABARD took place at the Conference Hall of NABARD, HO on 12<sup>th</sup> April, 2018 from 11:00 AM. The Meeting continued till 1:30 PM General Secretary, AIRRBOF attended the JCC Meeting on behalf of our Federation.

After confirmation of the Minutes of the 8<sup>th</sup> JCC Meeting held on 25<sup>th</sup> Sept. 2017, Action Taken Report was tabled by NABARD officials.

The new issues when were given by AIRRBOF as follows, were then taken up for discussion.

### **Issues:**

- (i) Stoppage of deputation of officers from Sponsor Bank other than Scale – IV & Scale – V and not junior to the officers of RRBs in the corresponding Scale.
- (ii) Compulsory inclusion of retired staff in the health insurance scheme as per IBA guidelines.
- (iii) Withdrawal of restriction on recruitment & Promotion in RRBs by Sponsor Banks.
- (iv) Filling up of all vacancies by recruitment.
- (v) Accelerated promotion scope both on merit and seniority channels.
- (vi) Up gradation of software package of RRBs and bearing of cost by Sponsor Bank and NABARD in matching basis.
- (vii) Scrupulous adherence to CVC Guidelines in regard to periodical rotation of officers across different offices in separate centres.
- (viii) Stoppage of attrition of newly recruited officers by holding recruitment test for RRBs post PSB and SBI recruitment process.

(ix) Compulsory sufficient proficiency in the State Language for recruitment in RRBs by amending the present APR.

All the nine issues were referred by AIRRBOF vide their letter no. 2022:15:2018 dated 30<sup>th</sup> March, 2018. Detailed deliberation took place on those issues. NABARD agreed to take up the issues with Govt. of India shortly.

It was clarified by NABARD that the discrepancy in regard to gratuity payment to officers only on Basic Pay is going to be ended by inclusion of DA by amendment in Service Regulation. Relaxation in eligibility criteria for promotion is also expected to be notified by Govt. of India shortly.

Thereafter, JCC Meeting ended.
