## **GENERAL SECRETARY VISITED ODISHA – ATTENDED MEETING OF OGBOU AT BHUBANESWAR**

It was decided to take organisational visit by General Secretary, AIRRBOF in order to strengthen the organisational bulwark in the two Officers' Organisation in the RRBs in Odisha, it deserves noting that while Utkal Gramin Bank Officers' Association is a cohesive organisation with lot of potential to grow, in the Odisha Gramya Bank dissensions, acrimony and lack of faith in the leadership had manifested over last one and half years. Majority of the officers of the Bank belong to AIBOC. But the organisational fabric is weak. A major section of officers had formed an organisation duly registered under Trade Union Act while the other section lack organisational zeal and did not have a proper organisational set up. However, the officers expressed their unstinted faith on AIRRBOF/AIBOC and pledged to remain part of it.

The major section organised under the banner of Odisha Gramya Bank Officers' Organisation had established negotiating status with Management and is the only registered Union of the officers in the Bank. General Secretary of our Federation continued to maintain working relationship with all the officer comrades of the Bank who pledged to remain part of AIRRBOF/AIBOC. During his visit to Odisha, the officers of OGB invited the General Secretary to address a major section of officers at Bhubaneswar. OGBOU organised an extended Executive Committee Meeting at the Hotel Pushpak in Bhubaneswar on 15<sup>th</sup> February, 2015. The Meeting was participated by large number of officers of the RRB.

With the welcome of the General Secretary, AIRRBOF the President of the Meeting, Com. Dibakar Nayak laid before the house the progress in the organisation, the efforts to emerge as the majority Officers' Organisation, the issues confronted by the officers and once again pledged their faith on AIRRBOF/AIBOC. With an introduction of the officers present in the Meeting, General Secretary, AIRRBOF talked on organisational process of

the officers, the need for maintaining of the Unity, and bringing the overwhelming majority of the officers under the banner of AIRRBOF/AIBOC. He stressed on halt to organisational infighting and build cohesive organisational framework. Lot of officers spoke on recent developments Com. Purna Chandra Panda, General Secretary, OGBOU placed a detailed report on developments on all fronts and the latest on the issues raised with Management. He then requested General Secretary, AIRRBOF to deliberate on National Level Developments.

Bhattacharjee deliberated at length the National Level Development putting up details of Salary Revision, Pension in RRBs and Govt. of India's move to amend RRB Act to pave the way towards privatisation. He also laid stress on united fight for achieving our demands of reasonable Salary Revision & Pension at par and thwarts the move to privatise RRBs. He assured the officers of OGB that the help, support and co-operation of AIRRBOF shall always be forthcoming to build up strong officers' movement.

Lot of officers participated in deliberations and lively interactions. Meeting ended with vote of thanks to all.
