**RRBs ACT AMENDMENT BILL 2014 – LIKELY TO BE  
TABLED IN THE RAJYA SABHA THIS WEEK OR NEXT  
WEEK. ALL CONSTITUENTS AND THEIR BASE UNITS SHOULD  
GEAR UP TO PROTEST BY RALLY/DEMONSTRATION BEFORE RESPECTIVE  
RRB HO/RO ON THE DAY THE BILL SHALL BE TABLED BEFORE RAJYA SABHA**

We reproduce hereunder the text of Joint Forum of Gramin Bank Unions letter no. JFGBU/2015/07, dated 24<sup>th</sup> February, 2015.

**QUOTE**

At the time we are celebrating the 10<sup>th</sup> Bipartite understanding on reasonable Salary Revision, the Government of India has decided to unleash a body blow to the existence of RRBs by passing of RRBs Act Amendment Bill, 2014. We understand that Ministry of Finance is expected to table RRBs Act Amendment Bill, 2014 before the Rajya Sabha in the late part of this week or next week.

It was decided in the meeting of JFGBU held on 15-01-2015 at New Delhi that as and when the Bill shall be placed in the upper house, appropriate organisational programme shall be observed at RRB level under the banner of Joint Forum. Accordingly it has been decided that lightening demonstration programme and rally should be organised before all RRB HO/RO on the day the Bill is tabled on the Rajya Sabha. We shall inform you the date.

We, therefore, in terms of our earlier circular, call upon our base units to keep them in readiness to organize massive Rally/Demonstration during Lunch time and/or at the end of office hour at respective HO/ROs along with sending an email/fax message to Hon'ble President of India in line with the text given hereunder:

**RRBs ACT AMENDMENT BILL 2014 IS AGAINST AAM ADAMI PARTICULARLY RURAL PEOPLE OF THE COUNTRY. WE APPEAL TO YOUR HONOUR TO DENY ASSENT TO THE BILL IN THE LARGER INTEREST OF THE NATION**
