THE HISTORIC STRUGGLE OF DBOO CONTINUES RELENTLESSLY!

We reproduce hereunder the text of All India Bank Officers' Confederation Circular No. 35 dated 19th June, 2015.

The agitation of DBOO is continuing relentlessly. Delhi, the capital of the country witnessed a sensational protest Dharna at Jantar Mantar, which is situated in the heart of the city and is hub of such activities. The relay hunger



strike was inaugurated by the General Secretary of the Confederation, Com. Harvinder Singh. Apart from him, the gathering was addressed by Com. Debashish Ghosh - Vice President, AIBOC, Com. Sunil Bansal - AIBOC, Delhi State Committee, Com. Ravindra Gupta - Jt. General secretary, AIBOC & GS - SBIOA, Delhi Circle, Com. Johny Jose - General Secretary, FBOA, Delhi, Pankaj Kapoor - Secretary, AIBOC and Com. Rajasekhar, President IBOO, Delhi. More than 30 comrades of DBOO observed hunger strike. Two officers viz. Com. Raji Sulochana Naidu and Com. B.S. Bali from Federation of Bank of India Officers' Associations also participated in hunger strike. All Comrades of DBOO posted in NCR region along with comrades of various affiliates, braving the scorching sun, expressed their anguish against the DLB Management.

By the evening there were more than 500 members at the Dharna site. The demonstration concluded at five p.m. after it was addressed by Com. Prakash Karotya, President, SBOA, and Com. Sunil Bansal, the State secretary, AIBOC, Delhi State Committee.

Dharna organized in front of Dhanlaxmi Bank, Regional office, Bangalore under the leadership of AIBOC President Com. Y. Sudarsan rocked the city. Apart from him, Com. A.N. Krishnamurthy Jt. Gen. Secy., AIBOC addressed the gathering.

Yesterday, a Board Meeting of Dhanlaxmi Bank was also held, in which termination of Com. P. V. Mohanan was one of the agenda to be discussed. To draw special attention towards misbehavior and unsavoury remarks being made by one of the top Management towards the lady comrades, a special hunger strike programme of the Lady comrades of AIBOC, Women's Wing of Kerala State, was organized coinciding the same. Five hundred raised arms punched the air in rhythmic succession to the slogan "Inquilab Zindabad" at Thekkinkad Maidan, Thrissur. Yes, it was a veritable display of women power of DBOO and AIBOC Women's Wing observing hunger strike! The noted writer and human rights activist Prof. Sara Joseph elaborated on the problems of the working class community being faced at work places, particularly by the women.
