RELENTLESS STRUGGLE OF THE FIGHTING COMRADES OF DBOO CONTINUES

We reproduce hereunder the text of All India Bank Officers' Confederation Circular No. 36 dated 24th June, 2015.

The fighting comrades of Dhanalakshmi Bank, amidst all odds, are keeping their head high and carrying on their struggle against a draconian, insensitive management of the Bank. The entire public of Kerala, along with the local media and political fraternity are getting involved in the struggle and has declared openly that they would stand by the valiant warriors of DBOO. Yet the passive Management has gone into a 'mute', mode.

The AIBOC held a meeting of the General Secretaries on 20th of June, 2015 at 4:00 p.m. Com. P.V. Mohanan briefed the house on the developments that led to the standoff and the highly negative attitude culminating in the vindictive action of termination of the General Secretary. Com. P.V. Mohanan also briefed the house on series of events leading to the two days strike call due to non-implementation of all the agreed issues.

The entire house expressed solidarity with the fighting comrades of DBOO and decided to intensify the struggle by escalating the issue to National level. The house also decided to observe two days strike at Kerala and one day strike by the AIBOC at the All India level. However it was decided to continue all efforts to keep open the channels of negotiation.

In the meanwhile on the 21st June the leader of the opposition V.S. Achuthanandan strongly criticised the Management of Dhanalakshmi Bank for its "anti-union stand and vindictive action against trade union leaders". He urged upon the Bank Management to cancel the termination order served on Com. P.V. Mohanan unconditionally.
