

JCC MEETING – NABARD DEBARRED OFFICERS TO REPRESENT WORKMEN UNION

In the 4th Meeting of the Joint Consultative Council (JCC), Secretary General, All India RRB Employees' Association attended the JCC Meeting on behalf of National Federation of RRB Employees' (NFRRBE). TA claim was made to Paschimbanga Gramin Bank (PBGB). Chairman, PBGB denied payment of bill and sought advice of NABARD, NABARD IDD vide letter no. NB.IDD.RRCBD/316(JCC)/2015-16 dated 23rd September, 2015 advised Chairman. PBGB that such officer representing workmen shall not be allowed TA & it is illegal for an officer to represent workmen. The letter of NABARD is enclosed.

Friends, the letter of NABARD vindicates our position that only AIRRBOF is the true representative of officers. All other Unions/Associations are two pockets of same organisation. Let us spread the message amongst membership and expand AIRRBOF net work.

Joint Consultative Council (JCC) – Fourth Meeting

Please refer to your letter no. PBGB/HO/PAD/522/2015-16 dated 19.5.15 on the captioned subject. As rightly pointed out by you, in terms of regulation 32 of RRBs (Officers & Employees) Service Regulation, 2010, no officer, who is not a workman within the meaning of the ID Act, 1947 shall become or continue to be a member or office bearer of, or be otherwise directly or indirectly associated with any trade union of the employees of the Bank who are workmen within the meaning of the Act, or a federation of such trade union. The provisions of this regulation are very clear and there is no scope for any ambiguity in respect of joining of unions/ Association of the employees by the officer(s). Accordingly, officers (who are not workman) cannot join and become a member of union of employees.

2. Incidentally, we inform that NABARD issues invitations in the name of union(s)/ association(s) to attend the JCC Meeting & not to the individuals.
